**1. Approval of the Separate Financial Statements at December 31, 2023, together with the Board of Directors' Report on Operations, the Report of the Board of Statutory Auditors and the Independent Auditors' Report. Presentation of the Consolidated Financial Statements at December 31, 2024.**

Dear Shareholders,

concerning the first point in the agenda of the Shareholders' Meeting called for May 7, 2025, we invite you to read the Annual Financial Report of Technogym S.p.A. ("**Technogym**" or the "**Company**") at December 31, 2024, approved by the Board of Directors of Technogym on March 26, 2025 and containing the draft Financial Statement of the Company and the consolidated financial statement, together with the Directors' Report on Operations, which includes the corporate sustainability report, and with the certification under art. 154-*bis*, paragraph 5, of Legislative Decree no. 58 of February 24, 1998, as amended.

The aforesaid documentation shall be made available to the public according to the manners and deadlines prescribed by legal regulations, together with the Report of the Board of Statutory Auditors and the Independent Auditors' Report.
